As a result, Canadian and U.S. manufacturers and distributors face much less of a risk of liability when they introduce inferior products into the Mexican market than Mexican manufacturers and distributors encounter in the Canadian and U.S. markets. Mexico's producer-friendly laws encourage manufacturers in all three countries to produce poor-quality products for the Mexican consumer. This Dissertation argues for the improvement of Mexican products liability laws to bring these laws more in line with those of the other NAFTA countries.
