Merrell Dow Pharmaceuticals, Inc.* and *Kumho Tire Co. v. Carmichael*.

As in previous editions, the Handbook provides complete coverage of all Kentucky decisions (Supreme Court and Court of Appeals) that construe or apply the Kentucky Rules of Evidence, and comprehensive coverage of both pre-Rules decisions and federal cases that provide helpful guidance on using the Rules of Evidence or are likely to be influential with the Kentucky courts.
